### 4.1.1.2. Petition to disaffiliate

Jesse reiterated arguments that the club has breached 1.d: there was evidence that two students were denied membership based on factional alignment. If this suspicion excludes people from involvement, and then what does the spreadsheet mean for allowing involvement. They have been treating people from different factions differently.

Harry responded, no notice was given to the club of the matters, and no attempt to resolve with the club. All club events are advertised to all members. Personal lives should not be conflated with club life.
Discussion about Georgia's exclusion - she does belong to a different faction. Harry's acknowledges the inappropriateness of the chat names that implied her exclusion, and has apologised to her.
There was a question about actual complaints from excluded membership - Bella states that she tried to join and has not been included. Harry responded that he has made the outreach via the club facebook and is willing to entertain all claims to membership.

Distinction between private and club events re-stated.
Harry asserts that no one has responded to his outreach regarding membership. Scarlett claimed that she had invited Bella to give details and would add her to the List, no such details were provided.
Harry had Eol form and Membership form - people uncomfortable with joining a party and want to come to events and check it out before committing. Both forms were provided in the group chat.
The discussion of the two members political affiliation was asserted to be in the context of political organising.
Committee member asked why the Petition was distributed under the phrasing of race, political ideology, and religion, conflating them together. Appears misleading to the grounds of the petition.
It appears that the petition was distributed without the grounds.
Chair believe that while there may be issues over memberships, this seems to be a matter for internal resolution.

Spreadsheet of members' political alignment is for factional organising. Rachel asked if there was a distinction between running the club and the factional outreach and highlighted the conflict that is inherent in this issue. C\&S Committee cannot adjudicate factional arguments.

More discussion about the validity of the petition. Jesse provided some evidence that his approach was different to Jordan's, and provided more context.

Control of membership is an attempt by a faction to monopolise a club for a factional gain.
This is an attempt to weaponise regulatory body to advance personal agendas.
