Given Students Council regards attendance to the clubs expo as a privilege of affiliation that can be removed through discipline, I move to rescind the decision made by the previous committee to ban Chinese Cultural Society, Chinese Debating Group and China Rural Education Initiative on the grounds that:
a. Although the decision is consistent with the expo policy, it did not comply with the discipline procedure set out in the regulations.
b. the Chinese Culture Society and Chinese Rural Education Initiative will be invited participate on the following conditions:
i. they acknowledge their policy breach at WinterFest 2019, and
ii. they accept formally that during the SummerFest expos absolute compliance with the policy is required at all times, and
iii. they will receive no warnings regarding breaches; and
iv. if they breach the terms of the policy they will be required to pack up and leave immediately and that they must comply with the department accordingly
c. BUT the C\&S Committee excludes the Chinese Debating Group from attending SummerFest on the grounds that the exclusion is included in the prescribed disciplines of Students Council.

There was long discussions on whether staff and/or Office Bearer (OB) observation is classified as evidence.

Justin Riazaty mentioned that observations can be vague, ambiguous and not official warnings.

Chris Melenhorst mentioned that staff and OB are trained and understand the policy and safety, and are concerned with unorganised crowd control.

Jordan Di Natale explained that Chinese Debating Group was separated and removed from entering SummerFest on the grounds of Students' Councils discipline petition.

Chris Melenhorst asked that the first point (a.) be struck from the Motion, as the Committee should not undermine it's own departmental administration via policies. This amendment was amenable to the mover.
