Big Pulse were extremely expensive. It would have cost between \$35,000-\$45,000
Election Buddy: Most comprehensive response. Jordan and Fiona had a Zoom meeting with Cara who works for Election Buddy. She provided us with valuable information that addressed our thoughts on the integrity of clear, unbiased elections.

OpaVote: They are very DIY. Clubs will have to do everything themselves. Their website is supportive, and general assistance is available.

There was discussion on what a reasonable quorum that is representative of the membership base, as well how a small quorum will impact a full committee election. How will the elected Executive conduct the club? Will they be supported by volunteer assistance if there is no General Committee?

Questions around Big Exec clubs and which positions are necessary. Committee decided that President, Treasurer, Secretary (and for faculty clubs the Education Officer too), must be elected, consistent with the minimum provisions set out in the C\&S Regulations. Clubs must advise C\&S and the Members which roles must be elected when they give Notice.
Also discussion around the minimum requirement regarding quorum. Committee decided on a feasible number.
