Training: Dependent on needs of the organisation

- Mental Health First Aid
- General disability awareness training Recommend Arts Access training for this. Some staff completed this training in 2014. Feedback, found it extremely beneficial.
- Staff who have received Relevant training to be identified via lanyards

<u>ACTION:</u> Stephanie to commence the implementation of some training with volunteers
