## 10.1. UMSU condemns the Alice Springs Youth Curfew

#### Preamble:

On the 27th of March the Northern Territory Labor government implemented a two week 'Youth Curfew' that bans people under the age of 18 from entering the Alice Springs town centre between 6pm-6am. The curfew, originally meant to expire on Wednesday April 10th, has now been extended by another six days, till the end of the school holidays on Tuesday April 16th.

The NT Labor party's response to an increase in 'civil unrest' has been to trap children inside. The 'High Risk' area spans 4km from one end of town to the other. Children who live inside this zone are locked inside for 12 hours of their day and if they come out, face the possibility of being charged by police. If children do not have a home - which is a situation that many face as the NT has the highest rates of

youth homelessness in the country - they are taken to a bail house or worse, prison. Furthermore, this curfew has disproportionately affected Indigenous youth who, due to years of government neglect, are much more likely to be without stable housing and subject to police harassment.

Rather than condemning Indigenous children in Alice Springs to a life of homelessness, police abuse, army deployments and prison sentences, the NT Labor Government needs to massively expand its access to welfare and social services in the region. The Melbourne University student union should be appalled by the Labor Party's increase of police powers and call for the immediate removal of the 'Youth Curfew' and a ban on any more punitive measures in the Territory.

#### Platform:

- UMSU condemns the Labor Party's recent 'Youth Curfew' scheme in Alice Springs.
- UMSU demands the immediate end to the curfew and removal of increased police presence.
- UMSU condemns this as racist policing and stands in solidarity with Indigenous people in the Northern Territory that have been subject to similar punitive initiatives their entire lives.
- UMSU demands that the close to 800 homeless children in Alice Springs be immediately provided with free and suitable housing.
- UMSU demands the Australian Labor Party stop enforcing systemic poverty and instead provide access to all necessary social services in Alice Springs and its surrounding communities. The half a million the NT government pledged to the NT Police on Tuesday is an appropriate start.

### 12. Other Business (Motions Without Notice)

**12.1.** UMSU condemns Labor's attacks on refugees in its recent deportations bill

#### Preamble:

The highest moral test of any government is how it treats those who flee to our shores with nothing except their humanity, reasonably expecting to find safety and stability in one of the wealthiest nations in the world. The Labor party has proved itself to be hell bent on failing this test as it pursues legislation to further persecute refugees.

The Labor Party is proposing an amendment to Australia's already draconian refugee policy that criminalises refugees who refuse to willingly return to regimes that are persecuting them; to sign their own death sentence. Under the proposed law, any refugee who does not voluntarily deport themselves once exhausting "all legal means", would face up to 5 years in jail and/or up to \$92,300 in fines. The Labor party's own national platform recognises that the legal means currently available are not "fair, thorough and robust", with refugees often arbitrarily denied visas with no reason given. While they acknowledge there may be valid reasons to resist deportation, they refuse to consider fear of persecution in your origin country as one of them.

This new law is especially hideous in light of the ongoing case against a refugee known only as ASF17, which will conclude in May. Facing persecution in Iran as a bisexual man and as a women's rights activist, he was forced to flee to Australia where he has been held in indefinite detention. If he wins his case, the government will be forced to release him and provide a bridging visa. The release of a queer, women's rights activist into Australia has clearly sent a shiver up the Labor party's already negligible spine, providing an impetus for Labor to rail against those fleeing almost certain execution.

Labor is also implementing an outright ban on accepting immigration from whole countries giving the government power to refuse visas to anybody fleeing persecution in Iran, Iraq, South Sudan, and many other states who do not accept involuntary deportations from Australia. It is abundantly clear that if you are one of the unfortunate people fleeing persecution by a regime who might refuse to take you back, the Labor party doesn't want you coming here at all.

UMSU must condemn this most recent attack on the rights of refugees by the Labor party and endorse the upcoming protest organised by the Tamil Refugee Council and Victorian Socialists, to oppose the bill. Student unions in Australia oppose the persecution of refugees by our government and extend our solidarity to those like ASF17 who are fleeing extraordinary violence and persecution.
