5.1. Chinese Debating Group

Christopher: the correspondence is their own document but it's more or less how it ran. In the actual meeting. CDG were happy to discuss a 12 month probation. We wanted them to be disaffiliated-like without actually disaffiliating the group.

This is because they recognise that they did a serious thing in terms of lying. But in the international debating community, their affiliation is important. It's important that they understand and feel rhey consequences but that they continue to operate. The C&S committee will discuss it and either uphold or not uphold the petition.

Tree: Where does that lie with insurance?

Reece: they will still remain on UMSU insurance but the big thing is they won't be able to attend Summerfest or Winterfest. It means they won't be able to book rooms, go to Orientation events as a club etc. My recommendation is we uphold their appeal.

# 8. Operational Business

8.1. CEO's Welcome to Council 2020

Justin Baré welcomed new councillors. He gave an overview of the upcoming issues in 2020.

- Issues of student policy and how they affect students (such as Special Consideration). He emphasized that maintaining the status quo isn't necessarily an improvement for students. This is an opportunity to improve processes, not just stop them, he said.
- University accommodation. There will be a briefing paper coming to Council from Advocacy which identifies the key issues and opportunities to campaign.
- Next year the Australian Human Rights Commission will be running a survey on sexual abuse, a problematic area of university life (abuse on campus). UMSU will continue to be involved in the University's Respect Taskforce. We are looking at ways to improve events to create a safe environment but also to provide support to students if abuse occurs.

- UMSU could generate its own Reconciliation Action Plan and councillors would be involved in formulating the plan.
- New student precinct people from the project team will be coming to speak during induction. Critical issues regarding space, payment for space etc.
- There is no longer a sail in North Court. This has a significant impact on what we do and how we do it. We are speaking with the University about what will happen as we need to maintain a level of programming.
- Encouraged councillors and expressed that he looks forward to working with them for the next year.

Christopher asked about Patrick Tidmarsh's role.

Justin: Getting assistance from the university is very difficult and making instances of sexual assault less likely and provide support when they do happen.

#### 8.2 2020 UMSU Budget

Hannah: I would like to move the 2020 UMSU budget.

Jack: The Change of Management plan is really important.

- Reece: There was a motion regards Destination Melbourne that has since been withdrawn.
- Tree: Destination Melbourne was a program that helped to teach students at the university how to navigate city life and it's a shame that it won't go ahead this year despite budget being allocated and Student Council wanting it to go ahead. A review would be really important throughout the year.

Hue Man: I'd like to see a program next year where we actively support students.

- Hannah: In the years that it has been running, costs have been rising but attendance dropping and in order for it to go ahead there should be a review.
- Jack spoke about the high costs of Destination Melbourne and that ways will be considered to make it more cost effective while delivering benefits to students.
- Noni: We need to make sure that it's working effectively for regional students and students from low economic backgrounds.

Tree: Who will be involved in the review? How will it be conducted? Who will be consulted.?

Justin: If Council approves a review, we will come back with a proposal with how it will run.

- Tree: What would be the vague plan?
- Justin: The vague plan would be testing that the objectives of the program are valid and how we could meet those objectives.
- Joshua Bruni: When Student Council passes money, it expects those programs to be delivered.

Molly: Host Program Directors are now employed by the Union.

Christopher: Under the SP&E line, there isn't a detailed breakdown.

Justin: A significant expense will be coffee vouchers for students participating.

Tree asked a question about types of employment.

Justin: If we have part time work we need to have a minimum of 8 hrs per week. Mentoring doesn't have this so they will be employed as casual staff. VCESS has honoraria as a more appropriate payment due to the nature of the work, this is after legal consultation. We are trying to reduce the instances where people are employed in casual positions.

#### Student Rep Departments

#### Activities

- Molly: What is the Twilight Festival? I believe it's in place of Sleepover? And what about ticket prices between students and non-students?
- Tree: Last year they had Greta Ray and Jack River, and attendance was better with live music. This is rebranding Sleepover.

Christopher: SoUP – did the OBs have strategies in mind to increase awareness?

Tree: We sat down with Rory to increase engagement. We put another \$5,000 onto SoUP and will employ a DJ.

Lachlan: This is not a sufficient breakdown to show where Bands, Bevs and BBQs is spent.

Questions around RSA.

Justin: Alcohol at UMSU events is at the Ida Bar and staff is responsible for the serving of alcohol. OBs need to consider what kind of event they want and what it encourages but alcohol safety is around the bar staff.

- Tree: To speak to the increase for Bands and Bevs, it's the biggest student engagement activity. Liam struggled to get some bands due to the cost. Having extra money is so they can draw in at least one big artist. They also give opportunities to smaller Melbourne bands and student bands.
- Raiyan: Activities SP&E what does this refer to?
- Tree: Oktoberfest, Trivia, all of those.

#### **Clubs and Societies**

- Jordan: It's very similar to last year but there are extra additions for the Commencement Ceremony.
- Mark: You've indicated that a second Clubs day may be held.
- Jordan: Most likely in week 1 or 2 if the Clubs Committee agrees.
- Tree: There may be associated costs with the movement of the Clubs Carnival in week 0 and the noise in the car park. A little bit extra funding may be required to ensure accessibility.

#### **Creative Arts**

No discussion.

#### Disabilities

Srishti: This year the department will take a different spin. We will be creating strong partnerships and working with the People of Colour Department.

- Jack: In regard to workshops and paying for them, how will you avoid conflict of interest?
- Srishti: The committee will be checking the applications. We will be following a similar format to how POC ran the anti-racism workshop.
- Jack: It's hard to make payments to people who aren't staff as it's for ambiguous work.
- Justin: This will be discussed at induction. If you are in a situation where you want to pay someone to do something, you must speak to Goldie first and she will provide you with advice on how to make payment of that kind. As an organisation we have a process in place to allocate funds appropriately.
- Molly: I think it's great you engage with groups like Origin. Do you plan to run any campaigns? What are activism grants?
- Hue Man: One of the things we'll be introducing next year is an access inclusion working group. I think there's a lot of issues with accessibility and disability. Activism grants – those grants are similar to what POC did this year. They allow visibility and space to run their ideas.
- Molly: This is for the creation of activism campaigns?

Hue Man: Not for attendance at protests but for banners etc.

- Srishti discussed office space.
- Max: I advise caution with renaming the collective. I take issue with the itemisation of the collective budget. I am disappointed that there aren't many outward facing Disability campaigns.
- Noni: I advise caution in changing the name of the department. What is the process for the activism grants?
- Hue Man: That's something we'll talk to Goldie about to make sure they're transparent.
- Tree: I want to ask about the budget line "imprint".
- Hue Man: It's actually a 2 line budget.
- Reece: Student Council is approving the whole allocation to departments, further breakdowns are subject to departmental committees.
- Joshua Bruni: I ran the Winterfest stall on behalf of Lucy and a lot of people came up to me and asked about who the department caters for, they thought it was only about physical disabilities.
- Gurpreet: Activism grants clarification why can't it be done through the department directly instead of giving it to external people?
- Srishti: We believe it should come from bottom up, different people have different skills.
- Molly: No OB can employ anyone, ever.
- Gurpreet: Compensation will be in gift cards and stuff like that, not money.
- Max: Activism grants concerned about you being passive here. I'd also like to examine the collective you're running, you've got five. I find it peculiar you don't have any Womens, Indigenous or People of Colour collectives.

Srishti: Emotionally is defined as using your emotions to fit the requirement of the work you are doing. Anything that emotionally affects them means that they are doing emotional labour.

## Education

OBs spoke about the events that will run.

Tree: About the camp, what were the engagement numbers and what will you be doing to increase the numbers?

Discussion around this.

Eleanor: With the allocation of grants, the union as a whole is already supplying funding to NUS.

Georgia: NUS affiliation is for membership but from Education it's for things like flights and accommodation. Last year money had to be moved from different budget lines to cover the expenses. The camp has a capacity for 100 people and the price of the camp doesn't change according to the numbers.

Mark: In terms of self catering and safe food handling, who will receive safe food handling?

Georgia: OBs and volunteers will complete safe food handling.

Tree: The cost of an individual camper this year was equal to 1.5 of every SSAF payment.

Charlie: This year the Education Department ran a campaign to record law lectures. It didn't get the support required in the law faculty.

#### Environment

Sophie gave an overview. She said that the budget has been reduced as it wasn't fully spent in the last years. She said that the department would like to have a zine and that SP&E has been reduced.

Tree: How many zines?

Sophie: Around 500-1000 copies depending on the advice we get from UMSU staff. In previous years the department ran the Summerfest store and an event. Last year it was juts a picnic. We've increased the Summerfest budget line because we want a picnic and Green Screen. Film rights are expensive. We also plan to bring in a tiny house.

Mark: On the SP line, there isn't much detail.

Procedural to change speaking time to a minute and a half for OBs to respond to questions.

Tree: I have some questions from Chris. They've allocated \$22,000 for Under Bunjil.

# Media

Joshua Bruni: Last year the Media Department allocated a lot of money towards events but the collective attendance has gone down significantly despite the money being allocated. How are you getting this engagement back again?

Bethany: We are very aware there's been a decrease in engagement in the collective. We'll focus on diversifying events. We want to target people from outside the collective to increase involvement.

Molly asked for the Radio Fodder listener numbers.

Sarah: We haven't been given the numbers but we can look it up for you.

Tree: From Chris: Who will run the training workshops, volunteers?

Bethany: The collective will have people specialising in these areas and they will run them.

Gurpreet asked why Print Graphics is used and called them a scab shop.

We are planning to print at Print Graphics based on history and good experiences in using them.

Annalise: How do you plan on engaging the Southbank campus in the coming year?

Sarah: I got in contact with Eric Gardener to make sure there are more events down there.

Joshua Bruni: I'm aware the major problem is you don't have a quote. Is there a way, Jack or Reece to allocate some of the budget to an increase in costs of printing to use a unionised printer?

Reece: If you have the time to research and find similar quotes, there is a way for it to happen this year.

Bethany: Some of us are a little uneducated of what a scab shop is. We just looked it up. We would rather use a unionised shop and will look into it.

Discussion around decrease in print numbers.

Verity gave speaking rights to Hayden.

Hayden: I've never seen a copy of Farrago distributed at Southbank. There is an increase in the number of design students. How do you plan to help engagement?

Sarah: That's something we want to start talking about.

Bethany: A lot of student at Southbank don't know we have a Media Department. We will change that. I'm a student who studies at Southbank.

Molly: I'm glad that online content is picking up.

Motion 9: To direct the Media Department OBs to produce the Radio Fodder listenership numbers by the end of semester 1.

Natasha: The increase to the budget comes from increasing breakfast.

- Food bank and resource bank with expansion what are the specifics of the storage?
- Mental Health Campaign \$1500 specific outcomes would be good to know
- Breakfast allocated \$1100 a week but you said you were spending \$1300 a week. The casual staff member at breakfast, are they to replace OBs?

Tash: There's some storage in the kitchen we have started using this year. We'd store the food packs in the kitchen.

Declan: It's difficult to map out the exact outcomes of the Mental Health Campaign right now.

Tash: We decided to lower the budget as we put money to food packs and we'll buy food on sale.

Casuals – running of the breakfast is a very intensive task. The OBs might be doing breakfast 3 hrs per day, then doing food orders. Our time is wearing thin. We need assistance so we can run campaigns etc.

Mark: I don't see how the increase in budget is justified when there are volunteers. Breakfast is not an ad hoc event, it's a regular planned event. There is the ethical question of allocating extra funds to some departments but not others. What is Justin's word on this?

Justin: That doesn't mean that people might be employed in other capacities that are voluntary. There will be different accountability and higher responsibility for people in paid positions.

Mark: Is there's a view transitioning from casuals to something ongoing?

Justin: I'm not sure of the specific breakdown, it won't necessarily be one person doing the same thing every week.

Raiyan: They already have a volunteer system in place.

Tash: This will be my 3<sup>rd</sup> year and I can confidently say that the number of volunteers fluctuates and you can't count on them solely.

# 9.1 Get those animals off those horses: condemning police brutality at IMARC

From October 28-31st, protesters blockaded the international mining and resources conference (IMARC), rallying against the climate criminals of the mining and resources industry. A conference part sponsored by the university of Melbourne.

The demonstration was organised as a peaceful blockade of the conference. However, from the get go the actions of police were excessive and endangered protesters.

Protesters were run over by police horses, with one breaking both her legs. Others we're grabbed and shoved unprovoked, while some were pepper sprayed at point blank range. There were over 50 arrests that week, with people from the blockade grabbed and detained without provocation.

A farrago reporter was also pepper sprayed for reporting away from the blockade.

Some of those who experienced this were University of Melbourne students, including some outgoing and incoming members of our students council. It is shameful that our university sponsored a conference that saw active police brutality.

A police officer attending wrote "eat a dick hippy" on his body cam to taunt protesters. There were reports that a police officer at the centre of an indigenous woman's death in custody was attending, and the actions of police on one day of the blockade were so excessive protesters witnessed other police pull them back.

This is police brutality - excessive violence used by police as control. But ultimately this brutality is happening every single day. Indigenous Australians and people of colour in our community are significantly more likely to be injured or killed by police and there is no justice.

Ultimately, the Government is enabling this. And they should be held responsible for the violence shown by police.

Those arrested in the protests are now facing legal consequences. A shameful display of suppressing democracy and the right to protest.
