In the first weeks of last semester, Queer Lunch was attracting between 50 and 70 students a week, with all the food going in about 15 minutes. Over the year we have increased our weekly spend, and stabilised to a regular attendance of 35-50 a week, but we are running low on money now to keep Queer Lunch going. This has been an amazing event for student engagement and forms the heart of Queer Collective, and we'd greatly appreciate the budget being topped up.

10.4. Solidarity with Casino Workers

For the past few months, workers at Crown Casino have been in negotiations for a new EA. Crown have decided to not negotiate in good faith with their employees despite their \$3.49 billion profit. This industrial dispute is ongoing, with a large rally outside the casino occurring in August. Many of the workers involved are students and from migrant backgrounds, two demographics which are up there as the ones most exploited at work.

Seeing as we call ourselves unionists, it is imperative that UMSU displays union values and supports these workers in their ongoing dispute.

UMSU stands in solidarity with the workers at Crown Casino in their ongoing dispute.

UMSU expresses its disappointment in the Biomed Students' Society for moving their Biomed Ball to Crown Casino after the large public rally. UMSU Students Council believes that engaging in businesses where workers in industrial action undermines the industrial strength of already vulnerable workers

UMSU Students Council, the Clubs & Societies Officers and the President will investigate ways in which to educate the student population about industrial actions to ensure that no UMSU resources are used in unethical businesses or where workers in a dispute are undermined.
