Preamble: On Friday March 13th students from across the country will be walking out of class to protest our government and universities in action on climate change. Students from the University of Melbourne will be coming together at 11:30am on concrete lawns to protest our university's lack of action on climate change before joining the Victorian state contingent at the State Library. There is no UMSU on a dead planet and we should be banding together to demand our university take significant and prompt action on this issue.

#### **Motions Without Notice**

#### 10.1 MOTION IN SOLIDARITY WITH THE WET'SUWET'EN STRUGGLE

Plans to build a US\$4.98bn Coastal GasLink gas pipeline project in British Columbia have been disrupted by a blockade camp established by a Wet'suwet'en clan, Union'ot'en. The Indigenous landowners have been struggling for over a year to protect their territory from various extractive companies who are trying to destroy it for profit. On the 10 February, the Trudeau government sent in Royal Canadian Mounted Police (RCMP) who attacked one of the barricades of this camp. Dozens of Indigenous matriarchs were arrested. It is increasingly clear that the police and the government are on the side of big business when it comes to the environment.

In response, for the past few weeks, Canada has been disrupted by tens of thousands of activists in major cities to fight for the environment. Indigenous and environmental activists have occupied railways and have forced Via Rail, the country's intercity service, to shut down the entire network. Canadian National, a freight carrier, has ceased most of its operations as well. Supporters in Vancouver blockaded the largest port in the harbour city for four days. Activists have targeted politicians' offices and shut down the legislature to British Columbia. The local branch of the International Longshore and Warehouse Union came to the demonstrators with a message of support and union members refused to cross the picket, causing the entire port to shut down.

This incredible display of solidarity from all sections of society is inspiring. It shows the links being drawn between climate change protesters and Indigenous land protectors. Despite the media trying to encourage anger towards the blockades, tens of thousands of people have come out in support. Most important this that the solidarity actions are being led by the youth all around the country. In Australia, in our fights for climate justice and land rights we can learn lots of this struggle, especially as the climate protests become more popular in Australia.

#### 10.2 UMSU needs to lead a radical climate movement.

#### Platform:

The need for a mass, radical climate movement is more stark than ever. The devastating bushfire season just passed shows that the climate crisis is not a hypothetical future, but a reality that is already upon us.

Clearly, the Liberal Party is too committed to business interests to take any action on climate. However, Labor are also firmly wedded to the fossil fuel industry. Their recent announcement of a target of net-zero emissions by 2050 is far too little too late. Albanese also stated that Australia, the largest coal exporter in the world, would continue to export coal long after 2050, showing that the ALP is not willing to take any action that would limit the profits of mining corporations. Instead of looking to parliament, UMSU must recognise the need to build a mass movement on the streets. The role of the Student Union should not be to run concerts or give student discounts, it should be to organise students to fight for their rights. Right now, that means helping to build the radical climate movement that is developing on campuses around the country.

Uni Students for Climate Justice is leading that movement. It called nationwide rallies of 100,000 people during the bushfire crisis, and is organising the March 13 Uni Student Climate Strike. UMSU should help build this movement and provide support to all the actions it calls.

UMSU recognises that both major parties are unwilling to take meaningful action on climate.

#### 10.4 No Cops on Campus

#### Preamble:

At the STEM fair all was quiet, but students were presently surprised by a visit from everybody's favourite state-sanctioned thugs in blue. Whilst UMSU supports all who come to university to educate and better themselves it is clear that their presence was not so much academic but to instead intimidate and silence any dissent amongst students who so selfishly want to safeguard their future existence on this planet. Indeed, the criminals at the helm of Rio Tinto and Exxon Mobil, knowing full well their complicit role in the climate crisis have demanded protection in their quest to deceive ambitious students into accepting a career in destroying the planet wholesale, and the state has seen fit to once again provide its thugs to protect the interests of capital rather than that of the so-called people it claims to represent. The fact that the police were present not to protect students but rather multinational corporations is simply another indication of the moribund decay of the neoliberal order into a police state.

These corporations, who have an established history of disregarding indigenous sovereignty, cracking down on activists with disproportionate vigour and outright supporting fascist regimes contrasts strongly with their glib, greenwashed rhetoric, which misleads students into getting jobs with employers who actively profit from plundering our futures.

Fortunately, a broad coalition of students staged a snap action to call out this intimidation and prompted a retreat of these brutes guarding the careers fair, but not before a brief visit to Union House. It is not our place to say the purpose of this, but the presence of the police inside a student space with a history of activism further demonstrates their only purpose today was to intimidate and silence student voices, and their occupation of our space is clearly a hostile gesture that must be resisted.

#### Platform:

- UMSU acknowledges the climate crisis as one of the paramount issues of our time, being a profound existential threat that demands immediate and radical action.
- UMSU acknowledges the role of private corporations, in tandem with the state, in driving this crisis, accelerating our collective demise in the ruthless pursuit of short-term profit.
- UMSU demands the provision of green jobs and a just transition, and encourages the university to be judicious in support of this goal by setting renewable targets and ensuring it only endorses employees who share this goal.
- UMSU recognises Victoria police as mere thugs who brutalise any dissent against the corporate oligarchy, whose actions like that seen at IMARC last year results in state-sanctioned

violence against peaceful protest in addition to the systemic racism, sexism, homophobia and ableism they uphold.

#### Action:

- UMSU condemns the university for their passive support of climate criminals like Rio Tinto and Exxon Mobil, and strongly recommends they cease any further promotion the fossil fuel industry as anything other than a (literal) dead end.
- UMSU shall call out the university's hypocritical approach to sustainability, noting that their words in support of green jobs and climate action ring hollow when they uncritically platform these vile corporations.
- UMSU condemns Rio Tinto and Exxon Mobil themselves, for so generously giving students the opportunity to participate in their own doom.
- UMSU reiterates that cops have no place on campus; their presence is unwelcome and serves only to silence legitimate criticism and re-traumatise victims of police brutality, particularly minorities who experience their oppression on a daily basis.

#### 10.5 Motion about the legalisation of abortion in Argentina

#### Preamble

Argentina is on track to become the first major country in Latin America to legalise abortion. This is off the back of years of defiant mass protests in the streets that have mobilised millions across the country — radicals in Argentina are showing the world how to win demands.

The campaign includes more than 350 organisations fighting for legal, safe, and free abortion in public hospitals — an essential demand in a country where a woman dies every two days from illegally administered abortions. Abortion is illegal in most of Latin America, predominantly a Roman Catholic region. The practice was banned in 1921. Terminations in Argentina are restricted only to cases of rape or if the pregnancy is considered dangerous. Criminalising abortion has meant that many women have to seek abortions through illegal means, putting their health and lives at risk. Argentinian women have not just accepted this injustice. The fight to legalise abortion has created one

of the most biggest radical feminist movements in the world. The movement is often called a 'purple tide' a radicalising, anti-capitalist feminist movement that not only protests against lack of abortion rights but also against austerity, imperialism and sexism.

Argentina shows that we need mass, radical movements to win even the most basic civil rights.

#### Platform:

- 1. UMSU stands in solidarity with the activists of the abortion rights movement as it continues in Argentina.
- 2. UMSU fully supports the struggle for abortion rights in Australia including struggles against the Religious Exemptions Bill which will make it more difficult for women to have access to abortions.
- 3. USM stands against police brutality, state violence, and structural sexism all around the world.

#### Action:

1. UMSU will put out a statement of support for the Argentinian protest movement.
