assault and harassment at the University is a whole-of-union issue and funding for action should

therefore come from the UMSU budget instead.

11.1 UMSU INTL: Request to seek legal council

Preamble

UMSU International would like to propose a group of constitutional and regulatory amendments to address issues such as the structure and honoria of Office Bearers in UMSU International. Whilst many of these issues have already been brought up to the Constitutional Working Group, and will be explored further, UMSU International lacks any engagement with Moores to draft amendments to address these issues. As many of the issues pertaining to both the structure and honoraria are legal in nature, UMSU International believes that it is imperative that the appropriate professionals are engaged to ensure that UMSU International, UMSU and its Office Bearers are invulnerable to complications brought up by these changes.

Motion: That the UMSU CEO be directed to open a tender for legal services to draft constitutional and regulatory amendments to address issues raised by UMSU International and proposals UMSU International puts forward to rectify these issues. This action should be concluded by 23:59 pm AEST Friday, 7th May 2021. Mover: Rachel Anya Aw Aw Seconder: Muskaan Hakhu Justin suggested that UMSU combine the dealings with Moores – having 2 parties work on the Constitution is not a great idea.
