Jack Buksh: \$72,000 will be going to NUS.

Archit Agrawal: There is a lot more that NUS needs to be doing.

We have a responsibility to do more than just the bare minimum to support NUS. I'd like to move we increase affiliation budget line by \$10,000 to \$95,000.

Xavier Dupe: UMSU should be giving as much as it can afford for affiliation to NUS.

Catriona Smith suggested a condition of reporting being involved in the motion for NUS.

Archit Agrawal said that he agrees with Catriona but that KPIs may promote anti union ideology across the country rather than help NUS.

Catriona Smith: I don't understand why you think KPIs would ever destroy unionism, just making sure the money is used well. Even basic goals like "it's towards campaigns".

Archit Agrawal: My concern is that if every union sets KPIs, it will be impossible for NUS to meet them and then it would work against them.

Jack Buksh: We have an NUS representative. UMSU affiliates to NUS but is represented by its delegates. It'll be impossible for NUS to enforce all KPIs but that's something for delegates, not for us.

Proposed amendment to motion from Archit: To move to increase the Affiliations budget line in the Student Council budget to \$95,000 and direct the President and

General Secretary to work on the KPIs and bring it back to the next Council for approval.

Justin Baré clarified that there's no expenditure allocated for this purpose at this time. In terms of amending the budget, there's no figure to amend or change.

Archit Agrawal: Not paying UMSU International students is exploitative. I am proposing this motion:

To recognise the need to work on UMSU INTL's honoraria, and that UMSU INTL office bearers have been unfairly treated by UMSU, as their work has gone unnoticed for far too long.

During these negotiations, UMSU will remain committed to ensuring that UMSU INTL's autonomy and their department's work is not negatively affected in any way.

UMSU is committed to honouring the UMSU X UMSU INTL agreement signed in September 2019, working to ensure that the history of UMSU INTL and MUOSS are preserved, and the need for independent international student movements at this University is recognised.

# 10.1 2020 Southbank Yearbook

#### Preamble

In November 2020 the Southbank Committee approved expenditure of up to \$1000.00 for the printing of a catalogue and yearbook for the graduating Visual Arts Painting cohort, following the university's refusal to do so. The expenditure was approved, however due to administrative errors, the payment was not made from UMSU before the end of 2020.

Evelyn Pohl, one of the graduating students, went ahead and paid the printing costs at \$412.50 with the expectation she would be reimbursed. Given this expenditure was approved before the start of 2021 OB's term, we ask that these funds come from the union's budget as opposed to our expenditure for Semester 1, 2021.

**Motion:** That Students Council moves \$412.50 from the union's budget for the reimbursement of Evelyn Pohl, graduating fine arts student, for the printing costs associated with a catalogue yearbook.

# **10.2 End Racism + Know Your Rights Booklet**

Preamble:

The End Racism booklet will serve as an Anti-Racism toolkit and will be bold in its honesty. It is crucial to educate people about Anti-Racism and Allyship as lack of sufficient resources and underfunding directly impacts academic progress of students. This contributes to the achievement gap which highlights the vast differences in academic performance across racial lines. Thus, the ultimate aim of this booklet is to dismantle the discrimination it brings to the education system. This booklet is also aligned with our End Racism campaign.

The booklet will have approximately 16 pages including a cover, and A5 size dimensions. The booklet unpacks the effects of racism on BIPOC students and aims to amplify the experiences of BIPOC. It consists of an educational resource list and highlights the importance of unlearning, acknowledging and allyship. One of the main focuses of this booklet is to educate students about intersectionality and inclusivity. It also guides students on accountability and responsibility. The booklet will also list action items to stand in solidarity with the fight against Racism.

The Know Your Rights booklet is the second booklet we want to produce. This booklet has been produced in the past by the Education Department, including last year. It includes key information on the Education Department, including the differences between Education Academic and Education Public. It also provides information on UMSU Advocacy and Legal, which is extremely important for us and for students, so they know where to go when an issue arises. It will also provide information on what the Education Department will be doing this year (eg. campaigns, collectives), and how to get involved. Additionally, it provides information on your rights at work and university (hence the booklet title). We will be updating sections of the booklet to make it relevant for 2021. Like the End Racism booklet, the Know Your Rights booklet will be printed in A5 and will be around 30 pages in length.

We will be printing 3330 copies of the End Racism Booklet, as UMSU will be producing 3330 tote bags for Summerfest and we want every student to receive a copy. We will be printing 500 copies of the Know Your Rights booklet so we can distribute these at the on campus stall. We have been advised by UMSU that we shouldn't produce more than 500 for the Know Your Rights booklet because there will be limited foot traffic this year. These booklets will be provided at the summerfest and will be displayed around the common areas at campus such as the Union House and Stop 1 when campus reopens.

# 14.1. Park Hotel Prison Protestor Fines

Over 40 of the refugees locked up in the Park Hotel have been freed. The protests outside the Park Hotel organised by the Campaign Against Racism and Fascism, Refugee Action Collective, and others, have been indispensable in forcing the government to release these people into the community. Shamefully however, Victoria Police has issued fines of thousands of dollars to activists trying to expose this crime occurring in the heart of Melbourne.

Platform:

- 1. Protesting is essential to winning the rights of refugees to freedom, citizenship and government support
- 2. As the representative of students, UMSU is an activist body that has a responsibility to organise and support left-wing protests.

Action

- 3. UMSU will donate \$1000 to Campaign Against Racism and Fascism to pay fines incurred through refugee protests
- 4. UMSU will donate \$1000 to Refugee Action Collective to pay fines incurred through refugee protests

# **14.2.** Victory for Park Hotel Refugees but the Fight to Free Them All Continues

# Preamble

Last week 46 refugees were given bridging visas and after 8 years of indefinite detention, they were released from their hotel prison on Swanston street.

Mostafa Azimitabar, one of the men detained in Park Hotel, called the day he was released, "the most beautiful day of my life". "For eight years, I was under a lot of pressure, torture, trauma and sadness, Now I am completely free. I feel like a new person." He said.

While 46 of the men imprisoned in Park Hotel have been released into the community on bridging visas, there are still 12 refugees in the hotel who have no idea if they will ever be released or remain in indefinite limbo. The release of some men and not others is yet another act of cruelty in the endless torture the Australian government inflicts on refugees.

A Bridging Visa is temporary, meaning the men who have been released will face the possibility of deportation in six months which makes it very difficult to find housing and work. The next step for the campaign is to demand that all refugees be settled in Australia permanently with adequate government support.

There are a number of groups that have been organising in solidarity with the Park Hotel Refugees. With both the Liberal Party and the ALP firmly for the indefinite detention of refugees, it will require mass protests or ordinary people to push towards real change. Daily protests have been called by 'Our Daily Protest outside Park Hotel' and weekly Friday protests by the 'Campaign against Racism and Fascsim.' These protests are essential for building resistance to Australia's disgusting torture regime for refugees And demanding not only are all refugees released but are provided with government support and free housing.

# Platform

UMSU supports the demand to settle ALL refugees in Australia permanently.

UMSU supports the demand for financial support and free housing be made available to released refugees in Victoria by the Dan Andrews Government.

UMSU recognises building protest action as an important factor in this latest victory for refugees.

Action

UMSU will provide material support to building future refugee rallies such as printing and encourage students to attend the rallies through their official UMSU social media pages and UMSU events.

UMSU will call on Melbourne University, a billion dollar institution, to provide free education to the Men released from Park Hotel with the desire to study.

#### **14.3.** Cut All Ties with Arms Manufacturers

The World Health Organisation has recently announced that their collaboration with Melbourne University's infectious disease researchers has been compromised by the University's links to weapons manufacturers.

University of Melbourne collaborates with Lockheed Martin through the STEIarLAB, a facility that the university uses to funnel engineering students into producing weapons that maim and kill.

Lockheed Martin profits from mass murder. Their missiles have rained down on schoolchildren in Yemen, while their fighter jets terrorise civilians in the skies over Iraq. Worse still, they are directly involved in the production of nuclear weapons- which have the capacity to destroy the entire human population many times over.

Collaborating with weapons manufacturers is the most violent symptom of our for-profit education system, which prioritises corporate research and collaboration over quality learning. Student activist campaigns like Books not Bombs have organised in the past to attempt to force the university to cut ties. Staff members like Tilman Ruff, who has campaigned for nuclear disarmament, have spoken out about Melbourne University's role in perpetuating the production of weapons of mass murder.

# 14.4. Stand with Democracy in Myanmar

Preamble:

On Monday morning, Military in Myanmar detained newly elected civilian government officials including the nation's State Counsellor Daw Aung San Suu Kyi, the President U Win Myint, several elected officials and activists in a coup attempt. Then, the military declared a "state of emergency" and announced that they would remain in power for one year. The internet and phone lines were also disrupted nationwide on that day. This came after the NLD (National League for Democracy) party won the 2020 general election in a landslide in November. The military and its backed party- USDP (The Union Solidarity and Development Party), immediately claimed the elections were fraudulent, though foreign observers and the nation's electoral commission declared there had been no significant problems.

This represents a blow to democratic reforms in Myanmar. Therefore, we ask UMSU to strongly condemns the action of Myanmar's military and stands with the people of Myanmar in this difficult time.

Platform:

-UMSU affirms its solidarity with the citizen led government of Myanmar

-UMSU stands against the military coup executed by Myanmar's army and any form of militaristic and anti-democratic governments

-UMSU urges the military to follow the rule of law, and to release those detained -UMSU supports all the civil servants who are participating in civil disobedience protest in Myanmar

# 14.5. Solidarity with Indian Farmer's Unions

CW: mentions of murder, death, and police brutality

The Indian government, led by the Hindu Nationalist Bhartiya Janta Party, is cracking down on the hundreds of thousands of farmers protesting at the New Delhi border since November 2020. Police in riot gear and paramilitary troops have recently started heavy fortification of three camps around New Delhi. They are building concrete barriers, digging TRENCHES, and cementing metal NAILS in the roads, in effect cutting off entry and exit to the sites. The supply of food and water has been halted in an attempt to starve them out.

Almost 200 farmers have died protesting in the streets of New Delhi and even more have gone missing due to police detention. On January 26, India's Republic Day, the police attacked hundreds of protestors with tear gas and murdered one peaceful protester.

The farmers have had all internet and messaging services blocked at the protest sites to prevent the flow of information to and from the protestors. The government has further attempted to disable the social media handle of the farmer unions, news websites, independent journalists, and civilians trying to cover the farmers for more than 12 hours on Monday after the government said users were posting content inciting violence.

Modi Government is now directly attacking any individuals who are trying to raise awareness about the issue. They have asked Facebook, Twitter, and Instagram to take down any posts that the government believes are spreading misinformation or inciting violence, making these companies complicit in the brutal assault against the rights of Indian farmers. We believe it is now time for us to fight back on all fronts.

A candlelight vigil will be held to express sorrow and commemorate the farmers who have perished during the agitation or have gone missing; to condemn and bring awareness to the human rights violation by the Indian Government against peaceful farmers; and to bring awareness to the cause of the farmers and their fight against the implementation of anti-worker agricultural reforms. This will be held at Federation Square on 7th February, at 7:30pm. We want to support them by financing some items needed such as candles and a megaphone speaker.

This event will not provide a platform to any Indian political parties and will instead attempt to condemn them for their silence on these issues. This event will not provide a platform for extremist views of any religion.
