Clause 48 of the UMSU Election Regulation requires the submission of a written report by the Returning Officer that details the conduct of the election and provides provisional results to be considered by the Electoral Tribunal.

Appointment

On February 23, 2010 Justin Baré, UMSU Manager, was appointed by the UMSU Electoral Tribunal as Returning Officer to conduct a by-election.

Notice of Election

The by-election related to the following vacant positions:

- Indigenous Student Representative on UMSU Student's Council;
- Members of the UMSU Indigenous Committee x 6; and,
- The following vacancies on the Victorian College of the Arts and Music Student Association (VCAMSA) Council:
- Campaigns Co-ordinator
- One representative elected by and from each of the following constituencies:
 - Queer Students (who is also an ex-officio and non-voting member of the Queer Committee);
 - Indigenous Students, (who is also an ex-officio and non-voting member of the Indigenous Committee);
 - International Students;
 - Graduate Students; and

- One representative each of the following academic units of the Faculty of the VCA and Music, elected by and from students of those academic units:
 - Art;
 - Drama;
 - Dance;
 - Film and Television;
 - Production:

Initial Notice of the by-election (Attachment A) was given by UMSU on February 26. The notice was displayed on the Student Union website and notice boards in Union House. On March 1 the Centre for Indigenous Education (CIE) distributed the notice via email to all students registered with the CIE. On March 3 the Faculty of the VCA and Music distributed the notice via email to all students enrolled in that faculty.

Notice of the election appeared in issue two of *Farrago*.

On Wednesday March 17 Mr Chris Heelan, Director, Centre for Indigenous Education, provided advice that all nominees met the eligibility requirement set out in the UMSU Regulations – Clause 8.1.5.

On March 19 Ms Christine Holmes, Acting Student Centre Manager, Faculty of the VCA and Music, advised that all nominees were enrolled as students in the Faculty and in disciplines relevant to their nomination.

Provisional Declaration

Subject to Clause 17 of the UMSU Election Regulations these results were declared provisionally and displayed on the Student Union website and noticeboards in Union House on Friday March 19 (Attachment B).

As all nominations were received unopposed and all eligibility requirements were met all candidates were provisionally declared elected.
